Check in / Check out

Check in starts on Saturday from 17:00. Return of the yacht on Friday no later than 18:00. Overnight accommodation on board possible till 09:00 on Saturday.
In order to avoid waiting time on check-in we suggest agents/clients to plan their arrival during afternoon hours and advise charter base on estimated arrival time.
